- FIRST Robotics: Bob was able to get \$10,000 grant from P&W and UTC for the Chaminade "Eagle Engineering" team, which won the Long Beach Regional Competition highest award: the Chairman's Award and will be competing in the National Championships in St. Louis on April 28-30.
